Florida statutes allow you the option to exclude Windstorm Coverage from your policy. It is important that you understand that excluding this coverage means you will not be protected for losses caused by windstorm, hail, hurricane, and tropical storm. This exclusion will apply to the entire annual term of your policy and to each renewal thereafter unless you instruct us otherwise. If you wish to exclude Windstorm and Hail Coverage from your policy, you must handwrite the following statement and sign below.

“I do not want the insurance on my home to pay for damage from windstorms. I will pay those costs. My insurance will not.”

All named insureds on your policy must also sign acknowledging the exclusion of this coverage.
